Purpose of the form

This is an application to ask for an extended supply of chronic or acute medicine.

We will review this request only when you need the extra supply of chronic or acute medicine, because you will be traveling for longer than one month, or up to and no longer than six months. **Please note:** the maximum period for extended supply of medicines we will consider is six months. We will decline requests for periods longer than this.

Should you change to an option with a smaller Chronic Medicine Benefit, cancel your membership, or if your membership is suspended during the period for which we have approved your extended supply of medicine, you may have to pay the costs yourself, or we may need to recover the money from you.

How to complete this form

1. Please complete the form in black ink, use one letter per block, and print clearly. Alternatively, complete it electronically by typing in the fields below. You need to apply at least 7 working days before you travel.
2. Complete one application form for each patient.
3. If the applicant is under 18, a parent or legal guardian must complete Section 1, and sign the application form.
4. The main applicant must complete Section 2.
5. To avoid administrative delays, please ensure this form is completed in full.

Please note

This is an approval for funding only and does not override any legal requirements that your pharmacist must comply with. You will need to have a valid prescription for the requested medicine and there are some medicines where the maximum quantity that can be dispensed is a 30-day supply.

Please also check the customs requirements and laws of the country you are visiting before you travel, to avoid any issues with travelling with your medicine.
